Clarksburg Beauty Academy & School Of Massage Therapy (OPE ID: 00895900) received education stabilization funds under Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"), Public Law No: 116-136. This Fund Report applies to the student portion received under the Higher Education Emergency Relief Fund that is designated exclusively for emergency financial aid grants to students.

The institution has received these funds and is distributing them in accordance with the CARES Act and implementing guidance.

- 1. The institution signed and returned to the Department the Certification and Agreement [for] Emergency Financial Aid Grants to Students. The institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide emergency financial aid grants to students.
- 2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students is \$49,864.

Clarksburg Beauty Academy & School of Massage Therapy Policy and Procedures for the CARES Act

All students who are currently enrolled and are participating in Clarksburg Beauty Academy's online and or distance training as of March 21, 2020, will be eligible to receive the CARES Act Higher Education Emergency Relief Fund/Student Aid.

Funding available from the U.S. Department of Education will be distributed equally among all eligible participants. Once all Certification Forms are returned, the institution will calculate how many students indicate need and divide that number by the total amount of funds that are to be distributed to students.

Any student on a leave of absence, was graduated, withdrew or has been dropped by the institution prior to March 21, 2020, will not be eligible to receive the funding. Any student on a leave of absence or in attendance between March 21, 2020 and *August 1, 2020* will be eligible.

However any student whose life may have been disrupted or facing financial challenges and struggling to make ends meet due to the impact of the COVID-19 pandemic prior to March 21, 2020 upon demonstration of such circumstance will be deemed eligible.

All students seeking assistance will need to complete the COVID -19 Certification form and return it to the school office no later than *July 14, 2020*. After this date students will not be eligible for any disbursement of this particular HEERF funding.

The Department of Education was awarded an emergency grant to assist students who were attending schools of higher education during the COVID-19 emergency school closing and lockdown social distancing requirements in March 2020.

The CARES ACT HIGHER ED Grant will be awarded to each approved higher education school. The school has to determine based on guidelines for how it will disburse the emergency funds to students.

When the school issues checks to students, they must sign that they will use the funds for one or more of the expenses listed on the CARES ACT Certification and Agreement document, for "food, housing, course materials, technology, health care, and child-care expenses". We will also give students the opportunity to forego the payment if they have not been financially affected and wish to donate their portion back to the school fund so we can reallocate funds to other students who may have a financial hardship.

The school will allocate CARES ACT Emergency Relief funds to students equally, based on the total number of enrolled students who were attending classes on 03/21/2020 when the school temporarily closed due to COVID-19 lockdown and who wish to participate in the grant funding opportunity. We will divide the number of attending students into the emergency fund grant amount and allocate funds equally to each student. This is grant money and will not have to be repaid.

The school was advised the government will begin releasing funds and accepting student certifications as of the opening fund date of 04/14/2020. The school applied for the funding on opening day 04/14/2020. We hope to receive funds within the next few weeks. Students will receive funds by check mailed to the home address.
